



## **Fly Fishing Trips & Tourism Ltd**

### **Booking condition and other important information**

Please note that it is essential that you read and understand the conditions of booking and about the services we provide. Fly Fishing Trips & Tourism ltd ('We/us') accepts bookings subject to the following conditions:

### **Validity**

Our trips prices have been calculated on the basis of a maximum number of three clients per trip are based on the cost of guide services. Our prices are therefore guaranteed for your present trip with us only, and not for further trips. Please note that changes to our trips (which can be significant) can and do occur. We will make every effort to keep you informed of any changes, but cannot be held liable for any alterations made.

### **Payment**

A booking/reservation is accepted only after we received payment of the deposit. We will then issue a confirmation invoice to you. Options to pay us in New Zealand dollars (fees to your costs) trip deposit and balance, balance to be paid 5 weeks prior to trip beginning

- by transfers from your bank account onto our bank account
- by credit card through PayPal

Once your payment and contracts returned signed in two copies to us, we will send you very detailed documents to prepare your trip in the best way possible.

50% "trophy fees" must be paid on booking date, full amount 5 weeks prior to trip beginning.

Trophy animal(s) not shoot, we refund you 100% of total "trophy fees" in New Zealand dollars before end of your trip.

Meat hunting "fees" are payable in New Zealand dollars to trip leader at the end of hunting days.

Receipt of the deposit will be taken as an understanding by us that you have read and agreed to abide by these terms and conditions.

### **Insurance**

Travel insurance is strongly recommended for all our travellers.

Your travel insurance should provide cover against injury, damage, death, accident, medical expenses, emergency repatriation and personal liability. We also recommend it covers cancellation, curtailment and loss of luggage and personal effects.

We strongly recommend that you take out travel insurance at the time of international flights bookings.

### **Cancellation by the traveller**

The date of trip cancellation is the date on which the written cancellation is received by us. The deposit ensures you the exclusive supply of personal hunting guide(s). Cancellation of your trip prevents us arranging alternative bookings for that period. If you cancel your trip with us at any time following receipt of the deposit, the following cancellation fees shall apply per person:

60 days or more prior to trip beginning – Loss of 50% of deposit

From 59 days to 30 days prior to trip beginning – Loss of deposit

Less than 30 days prior to trip beginning – Loss of deposit and balance except meat hunt 'fees' and trophy 'fees'

No refunds will be made if you voluntarily leave a trip for any reason after the trip has begun. Refunds will be at our discretion if you are involuntarily forced to leave a trip for any reason. No refunds will be made for any transport or services not utilized. You are strongly advised to take out cancellation insurance at the time of booking which will cover cancellation penalties in certain circumstances (Note: such insurance will not cover a change of mind).

## **Cancellation by us**

In the unlikely event that our trip leader, Mr. Alban BOITON, is unable to perform his duties due to accident, illness or other unforeseen event, a third party will be supplied. We reserve the right to cancel any trip at any time prior to departure due to terrorism, natural disasters, political instability or other external events which make it unviable for us to operate our planned schedule. We are not responsible for any incidental expenses that you may have incurred as a result of your booking such as visas, vaccinations, non-refundable flights, etc.

## **Passports and visas**

You must carry a valid passport and have obtained the appropriate visas when travelling with us. Please ensure your passport is valid for 6 months beyond the duration of the trip. It is your responsibility to ensure that you are in possession of the correct visas for your holiday. We cannot accept responsibility if you are refused entry to a country because you lack the correct visa documentation.

## **Responsibility**

You acknowledge that participating on a Fly Fishing Trips & Tourism Limited trip requires a degree of flexibility and understand that the trip's route, accommodation and modes of transport are subject to change without prior notice due to local circumstances. You acknowledge that it is necessary to have a reasonable level of physical fitness to allow you to take part in this activity without the need of assistance from others. While participating to a trip with us you agree to accept the authority of the appointed trip leader and local operators at all times. You are aware that participating to a trip within a group may involve compromise to accommodate the other group members' desires and physical abilities. You understand that we reserve the right to decline, accept, or retain any person as a member of the group at any time. You acknowledge that we contract with a network of companies, government agencies and individuals to assist in the running of our trips. Any damaged rental hunting gear will be to your costs.

To the best of our knowledge, these third parties are qualified to perform the duties they are contracted to perform. However we will not be held liable for any death, aggression, injury, damage, loss, or loss of enjoyment, helicopter incident or accident, delay or irregularity that may occur due to the behaviour of these third parties or during your trip or while you are hunting, domestic flights booking mistake incurring costs. We will not accept responsibility or liability for any of our clients who contravenes any law or regulation of New Zealand while on trip. These booking conditions and the supply of services herein shall be governed by the laws of New Zealand and both the client and Fly Fishing Trips & Tourism Ltd a revocable submit themselves to the jurisdiction of New Zealand courts in respect of any proceedings arising out of or relating to these booking conditions all services provided hereunder.
